


## Top






#### **Helpful Hints**

- If you have pets, keep them away from the puzzle. They love to play with the foam pieces. The foam is non-toxic.


#### Important Building Information


Vertical portions of your puzzle (such as walls) fit onto the horizontal portions (floors, rooftops, etc.) as shown in the illustrations below. You may find it easier to build the base of your puzzle first, then attach the wall pieces to the base.





Remember to refer to the different views of the completed puzzle on the back of your box when working on those parts of your puzzle.





#### Missing Puzzle Pieces
